We are proposing to build a new stand alone heifer raising pack barn beside our existing dairy barns. The proposed new heifer raising pack barn will house all our young replacement stock from 3 months to 24 months of age. We are proposing a heifer raising pack barn that will be suitably sized to accommodate replacement young stock numbers associated with a 500 milking cow dairy facility. The proposed numbers are for 500 Replacement Stock, which is an increase of 260 from our existing approval.

With the new proposed heifer raising facility built we will be able to move all our existing replacement young stock out of our existing milk cow barns, which will create pen space for an additional 100 milking dairy cows in the existing milk cow barns. We are including this additional 100 dairy cows and an additional 30 dry cows in this application.
