Permitted construction (based on the submitted site plan):

• Chicken pullet barn – 93 m x 30 m

The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions contained in the filed applications RA21006 and RA24008, together with the site plan, building plans, and other attached documents included, unless otherwise noted in the following conditions.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in condition 2.

## **Construction conditions**

- The concrete used to construct the liner of the new pullet barn must meet the specifications for category D (solid manure – dry), in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide written confirmation, from a qualified third party, confirming that the concrete used for the manure collection and storage areas meets the required specification.
- 2. The permit holder shall not allow birds or manure in the new pullet barn, until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
- 3. The permit holder shall complete construction of the manure collection and storage portions of the new pullet barn prior to October 31, 2025. Upon request, this deadline may be extended by the NRCB in writing.

This approval becomes effective immediately. The approval conditions will remain in effect unless amended in writing by the NRCB.



Approval RA21006 is hereby superseded, and its content consolidated into this Approval RA24008, unless Approval RA24008 is held invalid following a review and decision by the NRCB's board members or by a court, in which case Approval RA21006 will remain in effect.
